On the Street Where you Live By Linda Kaye

Sunset Mesa resident, Cora Scott, attended the LAWA meeting regarding the NextGen plane noise. The Next Generation Air Transportation System "NextGen" is the FAA-led modernization of America's air transportation system to make flying safer, more efficient, and more predictable. The FAA plans to continue implementing cutting-edge technologies, procedures, and policies that benefit passengers, the aviation industry, and the environment through 2025. Reportedly, MORE CHANGES COMING and they are NOT good. The plane noise from the Getty Villa gateway could severely impact property values. Approaching at 10k ft and lower, commercial air traffic now completes with private planes and helicopters, producing a noise war zone.

Recommendations made after the meeting include:

- City of Malibu should hire an aviation expert, to fully understand impact on the community. Beach communities have been significantly affected low-altitude helicopters and prop planes hugging the coast annoying tourists and residents.
- Request historic data from LAWA and/or Roundtable (e.g. dispersion graphs and altitudes) for the past year on flights over Malibu. This data is necessary to prove the changes. 67% of flights allegedly violate the FAA's minimum altitude restrictions.

- City of Malibu should separately request data on small prop planes and helicopters since the FAA and LAWA doesn't consider this a "NextGen" issue. The noise from small aircraft is a direct consequence of the NextGen changes.
- There are plans for a new holding pattern designed to stretch almost the entire length of Malibu. The new holding pattern will entail about 3-5 low-altitude planes circling 25 miles along the coast of Malibu as a result of delays at LAX. This could negatively impact several Malibu communities. The current noise problem will be nothing compared to circling airplanes.
- City of Malibu should consider filing a lawsuit or an amicus brief. Culver City already filed their. A lawsuit with the major airlines, may be effective since they are at the root of this problem. NOTE: Airlines paid \$10 million to former Senator lobbyists Trent Lott, John Breaux and Chris Bond in an effort to privatize the FAA. Airlines will save \$7.8 million annually in fuel savings. <https://www.faa.gov/nextgen/snapshots/metroplexes/?locationId=18>

- The FAA is currently testing new flight patterns. They will be posting 400 new changes every month for the foreseeable future (Malibu needs an aviation expert to understand these changes).

What can you do?

1. Volunteer to serve on the Airplane Noise Committee. For more information please email Tatyana Thompson, tatyanathompson@hotmail.com
2. Use phone app or website to complain about noise. LAWA NEEDS TO HEAR FROM AS MANY RESIDENTS AS POSSIBLE. Download the app at http://www.lawa.org/welcome_lax.aspx?id=12634
3. Keep pressure on council members to file lawsuits and engage with the LAW-Community Noise Roundtable.

How perps are targeting us: When you park at grocery stores or other nearby establishments, perps park next to you. When your car is remotely locked or unlocked they the remote code is recorded. Then they follow you home to see where you live, and come back late at night to break into your car. Locking and unlocking your car with the key, prevents this. If your car is keyless move your hand near the lock to open it and use the lock button inside your car when possible. If you think your remote is compromised, your car dealer can reprogram it for you.
